YCF's Yolo Youth Service Awards Program

Yolo Community Foundation has launched the Yolo Youth Service Awards, an innovative leadership development program.

The awards are designed to recognize the personal commitment to service which leadership requires. Each YYSA award will honor a high school senior who has dedicated substantial volunteer service to a local nonprofit during the last two years of high school. A financial award of \$2,000 will be divided between the graduating student and the nonprofit served. The student's portion must be used for further education.

This new awards program is in keeping with YCF's

role of fostering a civically engaged community and vibrant nonprofit sector.

Casson Scholarship Awarded

In June, **YCF's Timothy Casson Memorial Scholarship Fund**

awarded its annual scholarship to Ashley Kraintz. The fund provides \$1,000 to a Winters High School senior who plans to enter a trade or technical school. Ashley is the first in her family to attend college, and she intends to study pharmacy.

Established by Paul and Gail Casson to honor their deceased son, the Timothy Casson Memorial Scholarship Fund is supported primarily through an annual BBQ, known as *Picnic in the Park*, held in Winters. This family event features good food, horseshoes and other games, and a drawing to win beautiful, handmade quilts sewn by Gail. The Fund also accepts direct donations.

About receiving the award Ashley said, "This scholarship will make it possible for me to achieve my goals and also sets an example for my two younger siblings to attend college."

Nancy Shapiro is an acclaimed artist and jewelry designer, as well as a retired organic farmer and seed producer. Before moving to Davis, Shapiro lived for 16 years on the banks of the Rio Grande in Northern New



Mexico, where she and her husband, Howard, were certified organic farmers and orchard keepers. Together they founded Seeds of Change, an organic seed and food company, to demonstrate their commitment to biodiversity, organic sustainable agriculture, and organic seed production.

Nancy brings this expertise to our Board, as well as sharing her

experience with community outreach, education, and development. She also volunteers with the U.C. Sustainable Agriculture Research and Educational Program, the Arboretum, and the local Audubon Society. She and her husband have a daughter, Sedra, who works at the San Diego Foundation. **Mike O'Donahue** brings to our Board experience in nonprofit management and organizational development. Currently Executive Director of Heidrick Ag History Center, Mike has worked for the California Rangeland Trust, the Sacramento Tree Foundation, and the Nantucket Historic District Commission. From this



background blending preservation and agriculture, Mike is well versed in tax credit and conservation easement programs for both rural and urban land use situations.

Mike is a native Californian who grew up in a small Iowa farming community, where his father's family has farmed for four generations. He is also an architecture buff, having both studied architecture and worked in historic preservation, as well as personally renovating a number of historic homes. He is a member of the Woodland Sunrise Rotary Club, a father of three, and grandfather of two.

George Hinkle is a local treasure.

This athletic octogenarian bubbles with delight when he is enthusiastic about something. And he is enthusiastic about many things!

For one, he is an avid practitioner of living a healthy life. It wasn't always so. When George was 48, his doctor asked, "How long do you want to live?" The answer: "I want to outlive my dad." The doctor replied, "Right now my money is on your dad," and he advised George to quit smoking, lose some weight, and exercise.

By the age of 50, running in 10K competitive events became part of George's routine and later, at 57, he ran his first marathon. He has since run three. Today, his routine is to walk or run three days, weight train three days, and bike on Sunday. A cancer survivor, George credits his excellent physical condition with helping him to fight that disease.

George is also a tap dancer. He has performed several times this year - in May at the Veterans Memorial Theatre and this summer at American Cancer Society's Relay for Life events in

Davis, Auburn, and Woodland.

In addition, George takes time to volunteer for Citizens Who Care and for Rebuilding Together, as well as serve on the Davis Senior **Citizens Com**mission.



Did we mention he loves to tell jokes?

A year or so ago, having acquired a sizable amount of money from the sale of property in South San Francisco, George realized that for the first time he had the means to make a substantial financial contribution to others. A retired barber, teacher, and realtor, he had never thought of himself as a philanthropist. A friend suggested he talk to the Yolo Community Foundation.
